**2. Vacancy:** To meet with the immediate requirement of experienced Doctor, applications are invited from eligible Doctors for engagement as Part Time Visiting Consultant Doctor (General Physician), purely on hourly paid and temporary basis, for colony visit of DMRC Staff Quarters in NCR.

**3. Essential Qualification & Criteria: -**

- MBBS Degree from a recognized university or equivalent qualification, recognized by the MCI and registered with the Delhi Medical Council (DMC)- only current registrations shall be accepted.
- Preference will be given to those who are enrolled in other PSU's for similar assignment.
- At least five years' experience in the field is mandatory.
- Age as on 31.07.2022 should not be more than 60 Yrs.

**4. Other terms and Conditions:**

- The empanelled doctors shall be required to visit Delhi Metro Staff Quarter once/twice a week, as required.
- Appointment & Tenure:** - The engagement shall be purely on temporary basis for a period of 01 year. Further extension shall be reviewed at the end of the year on satisfactory performance only.
- Emoluments per month:** Rs. 2100/- (inclusive of transport, etc) per hour basis.

**5. Selection process:**

- The selection methodology will comprise Personal Interview. The candidates shall be shortlisted for interview on the basis of qualification and experience, in the relevant field. The selection process would adjudge different facets and candidates would be shortlisted for interview, based on their eligibility/ experience in the relevant field, etc.
